Harkey Family Papers (1989.39) Date Span: 1863-1930

The papers of the Harkey family papers primarily relate to D. Z. A. Harkey¹ (1845-1924), a long-time resident of Marysville Township, Miami County (just south of Spring Hill, Johnson County).² Harkey was a Confederate veteran³ who in 1868 married Mary Elizabeth Barkley and settled two miles east and two miles south of Gardner.⁴ D. Z. A. Harkey was the father of Dr. William C. Harkey.

COLLECTION DESCRIPTION

The papers of the Harkey family document several decades of their long-time residence in Miami County and has fragmentary coverage into southern Johnson County. The collection consists of two series: Correspondence and notes, and Financial Records. A limited portion of the collection relates to the medical career of Dr. W. C. Harkey

SERIES DESCRIPTIONS

SERIES 1: CORRESPONDENCE AND NOTES, 1863-1916

The series consists of three letters and a note and contains the earliest material in the collection--two letters from 1863, one from W. L. Harkey, a Confederate soldier and brother of D. Z. A. Harkey, and the other from a fellow soldier who reported Harkey's death.

SERIES 2: FINANCIAL RECORDS

The series primarily consists of banking records and legal documents, 1871-1930. The legal documents relate to the family's Miami County property. The series is arranged alphabetically by object type and then chronologically. Bank checks, deeds, and tax receipts are the most numerous items. Two of the four account books represent medical office records from Dr. W. C. Harkey of Gardner.
