## COLLECTION DESCRIPTION

The Joseph H. Vaughan Collection documents Mr. Vaughan’s political and community involvement in Johnson County during the late twentieth and early twenty-first centuries.

The collection is arranged chronologically at the item level, alphabetically at the folder level, and according to subject matter at the series level. There are seven series in the collection: Mission Area Chamber of Commerce (MACC); Leadership Northeast; Mainstream Coalition; Education; Shepherd’s Center of Shawnee Mission; Johnson County Republican Party; Personal Papers; and Johnson County Water Board District Number 1.

The collection is composed primarily of newsletters, personal and business correspondence, political literature and mailings, news clippings, and corporate documents. Whenever possible, photocopies of newspaper articles are arranged within their corresponding series.

## SERIES DESCRIPTIONS

### *Series 1: Mission Area Chamber of Commerce (MACC), 1993-2005*

This series contains material related to the MACC, including newsletters, correspondence, business directories, and other publications. Mr. Vaughan joined the chamber in 1993 and has served on various committees, as well as the board of directors. In 2001, the MACC and the Merriam Chamber of Commerce consolidated into the Northeast Johnson County Chamber of Commerce. This series also includes material related to neighboring chambers of commerce and Johnson County business and economic issues.

### *Series 2: Leadership Northeast, 1994-2003*

This series contains documents related to the Leadership Northeast program, a course designed to train citizens and businesspeople from Johnson County in leadership skills. The program was founded in 1989 under the cooperation of the Merriam and Mission Area Chambers of Commerce. Mr. Vaughan graduated from the Leadership Northeast program in 1994 and later served as a chairperson. The Northeast Johnson County Chamber of Commerce currently administers the program.

*Series 3: Mainstream Coalition, 1995-2003*

This series contains correspondence, announcements, and legislative updates from the Mainstream Coalition, “a non-partisan organization that promotes the separation of religion and government, and supports human rights, civil and religious liberties, and public education.”<sup>13</sup> The coalition remains active in Kansas and Missouri politics and has involved itself in state and federal elections. Mr. Vaughan became a member in 1994, and in 2003 he joined the group’s board of directors. Also included in this series are copies of the group’s newsletter, the *Messenger*.

*Series 4: Education, 1996-2004*

This series contains documents related to public education in Johnson County, particularly the Shawnee Mission School district and the Shawnee Mission Education Foundation.

*Series 5: Shepherd’s Center of Shawnee Mission, 2001-2005*

This series contains information related to the Shepherd’s Center of America, a network of organizations whose mission is to build and support a nationwide network of interfaith community-based centers providing meaning and purpose for adults throughout their mature years.<sup>14</sup> Volunteers assist senior citizens in a variety of ways, including providing meal delivery, help with household chores, and educational and social programming. Mr. Vaughan served on the board of trustees of the Shawnee Mission chapter of the Shepherd’s Center.

*Series 6: Johnson County Republican Party, 1995-2003*

This series contains material related to Mr. Vaughan’s involvement with the Johnson County Republican party organization. Campaign literature and mailings associated with Presidential, Congressional, state, and local elections are included in this series, as are documents relating to Mr. Vaughan’s own political career. In 1998, he was elected as the Republican Committeeman for his precinct, a position he has held ever since. In 2000, he ran for the seat on the Prairie Village city council. He campaigned on the promise of greater fiscal responsibility and an emphasis on upkeep of community services and infrastructure. In 2002, he ran in the Republican primary to compete for the twenty-fifth district seat in the Kansas House of Representatives.

*Series 7: Personal Papers, 1993-2004*

This series contains documents relating to the Johnson County Water Board, on which Mr. Vaughan has served since 2003. His committee assignments include memberships on the operations and retirement/investment committees and chairmanship of the community relations/public affairs committee.

*Series 9: Photographs*

This series consists of two photographic prints, portraits of the Leadership Northeast officers and directors. The images are filed in photograph collection print storage.

*Series 10: Objects*

This series consists of 12 objects present within the collection—3 plaques, 2 campaign buttons, and a scattering of other items. Each is represented by an object record and the items are stored in the appropriate locations.
